

Adult release form

1. ACKNOWLEDGEMENT OF INHERENT RISKS

I am aware of the inherent risks associated with outdoor camp activities as well as the inherent risks of being on camp property. Camp activities take place both indoors and outdoors locations, and may include but are not limited to: hiking, climbing, running, swimming, ropes courses, field sports, waterfront recreation, and shooting sports. As an adult I assume all risk of serious injury or death that may occur while attending camp, with the exception of gross negligence of Plains Baptist Camp Staff.

2. ACKNOWLEDGMENT OF FINANCIAL RESPONSIBILITY

In the event that I am injured on camp property or during camp activities, I acknowledge that I shall be personally liable for, and agree to pay, all costs and associated expenses incurred in connection with medical and/or dental services.

3. LIMITATIONS ON INSURANCE COVERAGE

I understand that my personal insurance coverage will be the primary coverage. Only limited secondary accident and illness coverage is provided by Plains Baptist Camp. I agree to the release of any records necessary for treatment, referral, billing or insurance purposes.

4. RELEASE AND HOLD HARMLESS AGREEMENT

I agree to release and hold harmless Plains Baptist Camp, its trustees, employees, agents and representatives for any injury, harm, or other damage by any occurrence in connection with my participation in camp activities.

5. PRE-AUTHORIZE FOR MEDICAL TREATMENT

As previously listed, I authorize any medical and/or surgical treatment, including but not limited to hospital care, to be rendered, as needed in the judgment of the treating physician, who is chosen by the Camp Director, or a designated representative working under him, as circumstances require. I further authorize Plains Baptist Camp Staff to render first aid and to administer medications as prescribed and received by the Camp Nurse at registration. I authorize Plains Baptist Camp to have a copy of my medical records.

6. ACKNOWLEDGMENT OF RESPONSIBILITY FOR DAMAGES

I agree to be financially responsible for any damage to camp property caused directly or indirectly, by my actions. .

7. CONSENT TO ADDRESS DISCIPLINARY PROBLEMS

I agree to fully cooperate with the adult leadership, camp staff, and other counselors. I agree that if in the judgement of the adult leadership or camp staff my presence becomes a discipline problem, that I may be asked to leave, and that I will forfeit all camp fees paid.

8. USE OF PHOTOGRAPH FOR PROMOTIONAL PURPOSES

I agree and consent that my photograph may be used for promotional purposes or publicity material by Plains Baptist Camp.

9. CAMP RULES AND POLICIES

I agree that I will adhere to the rules and policies of Plains Baptist Camp. I will also enforce these rules within my group of campers.

PBA prefers all females to wear a one piece swimsuit, if a two piece swimsuit is worn a dark cover must be worn over the suit. Boys and girls must wear a cover to and from the pool.

All transportation vehicles must remain on the road, please do not drive on the grass and adhere to a speed limit of 15 mph.

Golf carts, UTVs, and utility vehicles may be used by permission from Management.

All passengers must be seated in a proper factory installed seat. At no time should guest ride on the sides, bumpers, step rails, or bed of personal vehicles, including inside truck beds.

4-wheelers, 3 wheelers, and ATV's are prohibited.

Use caution when hiking. Always hike on marked trails and never cross fences along the camp property.

Smoking is prohibited in any buildings and within 20 feet of any building on the grounds.

Use of alcohol or any illegal drugs are prohibited on PBA grounds.

Guests of PBA are asked to dress modestly. Boys must wear shirts at all times outside of cabins. Shoes must be worn at all times.

Guests at PBA are asked to respect other group's privacy. PBA requests a "quiet time" between the hours of 11pm and 7am.

Appropriate language is requested of all guests of PBA.

Rattlesnakes are common to this area. If a snake is spotted do not attempt to catch or kill the snake, contact staff immediately.

Silly string and shaving cream fights are not permitted in or around buildings. Used water balloons must be cleaned up.

Pets are not allowed on camp property without special permission from the PBA management
